Master of Fine Arts Degree Typical Financial Support Scheme

Tuition is \$11,284 per year for 20 credits.

The 3-year M.F.A. in Theatre is a 60-credit degree. We give all out-of-state graduates a waiver that allows them to pay tuition at the instate rate. The listed \$11,284 yearly tuition cost reflects the in-state tuition rate.

Year One:

- We aim to provide each first-year student with a scholarship in the amount of \$10,000 for the year.
- We provide a work opportunity at an hourly wage in our production shops. A wage package is worth up to \$3780 per year based upon a 10-hour work week at \$13.50 per hour for 28 weeks. *Each semester is 14 weeks in length.
- The scholarship and hourly wages together can total as much as \$13,600 for the year.

YEAR two and YEAR three

- We typically provide a half-time, 50%, 20 hours per week position or a quarter-time, 25%, 10 hours per week position as a Teaching Assistant (TA). This means a job that pays a salary, respectively, of <u>\$19,570</u> per year or <u>\$9,786</u> per year. TA positions are granted on successful progress toward degree in the program. Typically, all 2nd and 3rd year students will have a TA position.
- With a Teaching Assistantship, the student is awarded a **Tuition Reduction Benefit** (TRB) rebate that covers 18 credits of tuition per year (for a half-time/50% position) or 9 credits of tuition per year (for a quarter-time/25% position). The scholarship awarded intends to cover the cost of the 10th credit for the Fall and Spring semesters.
- A scholarship of approximately \$1000 (year two) and \$1000 (year 3) is awarded.
- A half-time/50% appointment comes with UT health insurance through Blue Cross.

Translation to funding amounts for year two and year three:

- With a half-time/50% TA position, total tuition costs would be \$918 per year, and the student would have a salary and scholarships
 of a total income of \$20,500 per year.
- With a quarter-time/25% TA position, total tuition costs would be \$6101 per year, and the student would have a salary and scholarships of a total income of \$12,750 per year.

Since the University of Texas will not withhold federal income tax from fellowship stipends, Fellows must make estimated tax payments. If the student is a foreign student and his/her country does not have a tax treaty with the United States, 14% for Federal income tax will be withheld from the fellowship stipend checks.

Fellowships:

University, College, and Departmental Fellowships may be available that offer alternate and often greater financial support. These fellowships are limited in number, are distributed within the whole department, and vary in availability from year to year. Area Heads make requests and argue for candidates through a departmental process, including consideration from the Graduate Executive Committee, The Theatre and Dance Department Chair, and the College of Fine Arts Dean.
